Please note the following amendments to the above-mentioned Direct Access EOI document –

“4.2 (4) Development agreement for the property from where direct access is proposed

4.2 (5) Ownership document for the property from where direct access is proposed”

It is clarified that any one of the above documents establishing ownership / commitment of development rights on the plot / property, for which direct access is being pursued, in the name of the developer shall suffice. Additionally, an Affidavit / Power of Attorney by the plot / property owner, stating that development rights is being granted to the developer, will also suffice.

“4.3 A preferred alignment connecting your property to the unpaid section of the Metro Line 3 station is to be submitted”

The above can be in the form a google earth image; MMRCL is interested in understanding where within your property can the subway locate / terminate

“5.1 The application form along with the accompanying documents should be submitted in a closed and sealed envelope duly super scribed with “Direct Access to Mumbai Metro Line 3 Stations” on or before Friday, 20 December 2019 by 6:00 PM addressed to Executive Director (Planning), MMRCL”

The above clause has been changed to “The application form along with the accompanying documents should be submitted digitally by email to swetal.kanwalu@mmrcl.com with subject line “Direct Access to Mumbai Metro Line 3 Stations” on or before Friday, 20 December 2019 by 23:59 hours addressed to Executive Director (Planning), MMRCL
