1. The Mumbai Metro Rail Corporation (MMRC) has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Project Mumbai Metro Line 3 (Colaba-Bandra-SEEPZ). It is intended that part of the proceeds of this loan will be applied to eligible payments under Contract for the work as specified at Para 3 below and detailed in the Bidding Documents.
2. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans and is open to all Bidders from eligible source countries, as defined in the Loan Agreement.
3. The Mumbai Metro Rail Corporation (MMRC) now invites sealed Bids from interested eligible Bidders for completion of "Design, Manufacture, Supply, Installation, and Testing & Commissioning" of
 - (a) **Lot I: Blow Down Plant along with Comprehensive Maintenance Service,**
 - (b) **Lot II: Well Wagon,**

As per the Bidding Documents. International Competitive Bidding will be conducted in accordance with JICA's "**Single-Stage Two-Envelope Bidding**" procedure.

A complete set of the Bidding Documents may be purchased by interested Bidders on submission of a written application to the address above and upon payment of a non-refundable fee of **INR 11,800 (Indian Rupees eleven thousand eight hundred only) inclusive of GST or USD 145 (US Dollars One hundred forty-five only) or EURO 135 (EURO One hundred thirty-five only) or JPY 20000 (JPY twenty thousand only)** in the form of a demand draft in favour of Mumbai Metro Rail Corporation, payable at Mumbai between **10:00 hrs to 17:00 hrs from 28/02/2023 to 18/04/2023.**

Alternatively, applicant can also download the Bidding Documents from the MMRC's Website: www.mmrc.com. The applicants, who have downloaded the Bidding Document, shall be solely responsible for checking the website for any addendum /amendment issued subsequently to the issue of Bidding Documents and take into consideration the same while preparing and submitting the bid proposal. **The requisite non-refundable fee as mentioned above** in the form of a demand draft in favour of Mumbai Metro Rail Corporation Ltd., payable at Mumbai, shall be payable before or at the time of submission of Bids.

6. The Pre-bid Meeting shall be held at the address mentioned in point No. 4 on 14/03/2023 at 15:00 hrs. Bids must be delivered/submitted to the address given above on or before 15:00 hrs on 18/04/2023 and must be accompanied by a Bid security for **Lot I: Blow Down Plant of INR 3,00,000/- (Indian Rupees Three Lakh only) or USD 3,650 /- (US Dollars Three Thousand Six Hundred fifty only) or EURO 3,450 (Euros Three Thousand Four Hundred fifty only) or JPY 500,000 (Japanese Yen Five Hundred Thousand only).**
Lot II: Wagon INR 6,00,000/- (Indian Rupees Six Lakhs only) or USD 7,300 /- (US Dollars Seven Thousand Three Hundred only) or EURO 6,900 (Euros Six Thousand nine hundred only) or JPY 1,000,000 (Japanese Yen One million only)
