## **Terms of Reference**

**Subject-** Appointment of Agency for undertaking Environmental Impact Assessment (EIA) for Metro Line 11 (Wadala to SPM Circle)

### A. Scope Of Work: Environmental Impact Assessment

A review on a scale appropriate to the Project, of the legal framework including gaps, if any, between local laws covering eminent domain and resettlement and the January 2022 JICA Guidelines (effective from 1st April 2022) for environmental considerations. Assessment of wide impacts for EIA required.

### I. Environment Impact Assessment (EIA)

- i. Description of the proposed project: To provide a brief description of the relevant parts of the project, using maps (at appropriate scale) where necessary, and including the following information: location; general layout; size, capacity, etc.; pre-construction activities; construction activities; schedule; staffing and support; facilities and services; operation and maintenance activities; required offsite investments; and life span. Study on analysis of Alternatives at an early stage of the project is required as per Clause 2.4 (4) of January 2022 JICA Guidelines.
- ii. The aspects of infectious diseases such as HIV/AIDS, working conditions including occupational safety to be covered as per Clause 3 (1) of Appendix 1 of January 2022 JICA Guidelines.
- iii. Legislative and Regulatory Considerations: To describe the pertinent regulations and standards governing environmental quality, health and safety, protection of sensitive areas, protection of endangered species, siting, land use control, etc., at international, national, regional & local levels. CRZ regulation to be assessed as extension alignment will traverse through CRZ area of South Mumbai. Accordingly, requirement of forest clearance also to be assessed.

#### iv. Description of the Environment:

- (a) Physical environment: geology; topography; soils & muck; climate and meteorology; ambient air quality; surface and ground-water hydrology; coastal and oceanic parameters; existing sources of air emissions; existing water pollution discharges; and receiving water quality; ambient noise quality and vibration monitoring; to be prepared as per latest JICA Guidelines and existing legislations of monitoring.
- (b) Biological environment: flora including mangroves; fauna; rare or endangered species; sensitive habitats, including parks or preserves, significant natural sites, etc., species of commercial importance; and species with potential to become nuisances, vectors or dangerous.
- (c) Socio-cultural environment: population; land; planned development activities; community structure; employment; distribution of income, goods and services; recreation; public health; cultural properties; tribal peoples; and customs, aspirations and attitudes.
- v. Identification of boundary of recorded forests/mangroves & collection of data from Forest Dept.

- vi. Estimate the number of trees for removal (Cut + Transplant) and trees to be retained with details of Height, Girth and Name of Species etc.
- vii. Field reconnaissance: Vegetation distribution, important fauna and endangered fauna.
- viii. Inventory Survey of Sensitive Receptors: Sensitive receptors such as schools, hospitals, religious places, heritage sites as listed by ASI, within 100 m from centre line of the proposed metro corridor to be identified using satellite images, field reconnaissance & interviews with local residents.
- ix. Noise and Vibration Measurement: existing vibration measurement at sensitive receptors along the metro corridors, existing air quality and noise measurement at key locations along the metro.
- x. Identification of major water bodies likely to be affected, measurement of water quality; Temperature, pH, electrical conductivity, DO, TSS, BOD, COD, Phosphates, Turbidity, Heavy metals, TDS, Oil and Grease, Chloride, Sulphate, Nitrate and Nitrite Nitrogen, RC, Bacterial analysis (E coli, Faecal coliform and total coliform), etc. to be analysed for surface and ground water in the identified water bodies and collection of existing and published data on water quality.
- xi. Socio-economic data on demography, social status, local economy, local culture & customs and land tenure to be collected through the Socio-Economic Survey.
- xii. Existing data on air quality, water quality, soil, status on solid waste, etc. to be collected, interviews with experts on the relevant field to be conducted, if necessary.
- xiii. Preparation of Environment Management Plan (EMP) and Environment Monitoring Plan (EMoP) based on analysis of collected data, mitigation strategy. EMoP to be finalized incorporating feedback from local residents participated in Public Consultation Meetings. Detailed impact analysis (both negative & positive impacts) on physical and biological environment and analysis of social impact to be included;
  - (a) EIA, EMP and EMoP will be finalised as per latest JICA Guidelines by assessing impacts with regard to environmental and social consideration that includes impacts on human health and safety as well as on the natural environment.
  - (b) Project and environmental benefits of the project will be evaluated.
  - (c) Analysis of an alternative at an early stage of the project (Clause 2.4 (4) of January 2022 JICA Guidelines).
  - (d) In addition to the direct and immediate impacts of projects; derivative, secondary and cumulative impacts as well as impacts associated with indivisible projects will also to be examined and assessed to a reasonable extent including the impacts through a project life cycle (Clause 3 (2) of Appendix 1 of January 2022 JICA Guidelines).
  - (e) Total amount of Greenhouse gas emission will be estimated and disclosed before project implementation (Appendix 1 Clause 6 (1) of January 2022 JICA Guidelines).
  - (f) Parameter Odour, sediments and subsidence will also be covered in physical environment Appendix 6 (pollution control) of January 2022 JICA Guidelines.
  - (g) Management of abandoned sites will be considered Appendix 6 (natural environment, protected areas) of January 2022 JICA Guidelines. This apparently refers to restoration of muck disposal sites.

- (h) Establishment of Grievance Redress Mechanism (GRM) Appendix 1 (Clause 11) of January 2022 JICA Guidelines.
- (i) Assistance will be provided for conducting consultation with stake holders such as local residents during selection of items to be assessed as well as at completion of the draft environmental assessment report Appendix 2 (Environmental Assessment Report) of January 2022 JICA Guidelines.
- xiv. EMoP to be finalised by taking into consideration JICA requirement of frequencies and also existing regulations of monitoring environmental parameters for Air, Water, Noise, Vibration, Soil/Muck.
- xv. EMP preparation shall consider the standards of water pollutant parameters prescribed by NGT Order(s) for sewage treatment plant.
- xvi. Identification of Institutional needs to implement Environmental and Social Assessment Recommendations: Review the Authority & capability of institutions & recommend steps to strengthen or expand them so that the management & monitoring plans in the environmental assessment can be implemented.
- xvii. Assist in coordinating the environmental assessment with other government agencies, in obtaining the views of local NGO's and affected groups.
- xviii. Disaster Management Plan to be prepared.
  - xix. Risk assessment of the project needs to be carried out.
  - xx. Environment budget to be evaluated & considered in Cost Estimates.
