Your Representation vide above ref.(5) for deletion of condition that "MMRCL to follow the stipulations and provisions of Noise Rules, 2000 (amended from time to time) while implementing the work of Metro Line-3." Stipulated in amended CRZ clearance SEIAA-2018/CR-36/Est dated 17/04/2018 for (1) Vidhan Bhavan, BKC and Dharavi Metro Stations and allied activities [ref.(1) above], (2) Worli and siddhivinayak Metro Station and allied activities [ref.(2) above] and (3) Alignment proposal (laying of underground tracks and construction of underground tunnel Colaba-Bandra-SEEPZ) [ref.(3) above] was considered in 134th meeting of SEIAA held on 30/07/2018. Minutes of the meeting are enclosed herewith. The Authority observed that, as per Govt. of Maharashtra Resolution dtd. 21.04.2009, the responsibility of effective implementation of Noise Pollution (Regulation & Control) Rules, 2000 is not entrusted to MCZMA and SEIAA.

After detailed deliberation Authority decided to amend the CRZ clearance granted on 17.04.2018 to the above proposals by deleting the said condition imposed in the amended CRZ clearance vide SEIAA-2018/CR-36/Est dated 17/04/2018. Accordingly, the condition to "follow the stipulation and provisions of Noise Rules, 2000 (amended from time to time) while implementing the work of Metro Line-3 project" as imposed in respect of (1) Vidhan Bhavan, BKC and Dharavi Metro Stations and allied activities (2) Worli and siddhivinayak Metro Station and allied activities and (3) Alignment proposal (laying of underground tracks and construction of underground tunnel Colaba-Bandra-SEEPZ) stands deleted.

The other terms and conditions in the CRZ clearances mentioned above shall remain same.
