#### 3. Introduction

#### 3.1 About MMRCL & Project

Mumbai Metro Rail Corporation, SPV, JV of Government of India and Government of Maharashtra is executing Mumbai's first fully underground Metro corridor; Colaba-Bandra-SEEPZ Metro-3. The corridor has been divided in seven civil packages and construction activities are in full swing in all packages. This 33.5 KM corridor will have 26 underground and one at grade station with 52 M long tunnel. Under this project, 11 Tunnel Boring Machine Launching Shafts will be constructed at various locations of the city and 17 TBMs will be launched through the shafts for the construction of tunnel. For the first time in the India total 17 Tunnel Boring Machines will work in Mumbai at a time. Geology of Mumbai congested work site etc. have posed the challenges in execution of this project. It is one of the most complicated infrastructure project in India and considering importance of the Project it is necessary to capture every event and activity of the project at various phases of the construction and keep in record so that it can be showcased for future learning and information dissemination.

#### 3.2 Objectives:

- To prepare High Definition Documentary (Audio Visual) on implementation of Mumbai Metro Line 3 covering special events and activities for the entire project development phase of required quality and version, to telecast globally on infotainment or educational satellite channels.
- To facilitate as study& research material for Engineering education.
- To create documentary evidence of Project implementation.

## 4. Scope of the Project

Following should be the thematic centre of the documentary:

- a. Key phases of the project
  - i. Planning phase: The need for it Increasing population, insufficient public transport, Safety of commuters, Environmental issues, Increasing Pollution, etc.
  - ii. Pre-construction Phase
  - iii. Construction phase
  - iv. Testing & Commissioning
  - v. Operations
- b. Key Engineering Aspects of the project
  - i. Construction Technologies Tunnel Boring Machines, NATM, Cut & Cover Method
  - ii. Construction Challenges Narrow streets, heritage structures, construction in city that never sleeps.
  - iii. The Tree Transplantation
  - iv. Safety Challenges
  - v. Rolling Stock, Electrical Units, Signaling & Telecom, Ticketing, Transport Integration etc.
- c. Brief Deliverables
  - i. Production of the documentary which shall include conceptualizing and scripting.
  - ii. Location & site shooting capturing all the events and construction activities.
  - iii. Designing and editing (GFX, VFX, etc.)
  - iv. Sound Design & Recording.
  - v. Maintaining the broadcasting standards.
  - vi. The scope shall also include following production, pre-production & post production activities:
    - a. Cinematography
    - b. Content Creation
    - c. Editing
    - d. Dubbing

- e. Graphics / Special Effects
- vii. Videos shot should be of High Definition i.e. 1080p and above
- viii. The documentary shall be of 20 to 40-minute duration.

## 5. Eligibility Criteria

- i. The entity should be registered firm in the field of production of Audio visual documentary, having single status or Joint venture with not more than 2 firm is allowed.
- ii. The entity should be registered under companies Act,1956 with annual average turnover for last 3 years should not be less than Rs. 1 crore
- iii. The bidder should have minimum five years' experience in the field of production of audio visual documentary with in-house facilities & support for editing, publishing, content writing, multi-language support, broadly classified into Pre-Production, Production & Post Production Activities respectively.
- iv. The entity should have atleast five years' experience of creating Audio-visual documentary, out of which atleast three years' experience on government mega infrastructure projects like Railways, Highways, Port etc.
- v. The Bidder must have production experience of 3-5 Audio-visual documentaries (including the ones which have shooting via drones as a part of it)on internationally recognised infotainment satellite channels.
- vi. The agency should have individual professional experts in the field of:
  - a. Cinematography
  - b. Content Creation
  - c. Editing
  - d. Dubbing
  - e. Graphics
- vii. Should not be blacklisted/ terminated/ indulged in any kind of corruption.
- viii. Agency should have the capabilities to produce multi-camera events with in-house on-line editing set-up along with drone arrangement and standby tie-up with other studios.
- ix. The Agency should be registered with the concerned tax authorities such as TIN/TAN, PAN, Goods & Service Tax as applicable from time to time and other authorities, copy of certificate to be submitted along with Technical bid.
- x. Agency should have its own Post-production facilities with editing machines that can facilitate audio-visual documentary in HD and 4K format for colour correction, grading and basic graphics, animation & sound effect.

- xi. Agency should be a private limited company with facility setup in Mumbai.
- xii. The agency shall have drone based infrastructure mandatorily.
