- The Mumbai Metro Rail Corporation (MMRC) has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Project Mumbai Metro Line 3 (Colaba-Bandra-SEEPZ). It is intended that part of the proceeds of this loan will be applied to eligible payments under Contract for Design, Manufacture, Supply, Installation, Tesing & Commissioning and Comprehensive Maintenance Service of Automatic Train Wash Plant as per the Bidding Documents.
- 2. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in the Loan Agreement.
- 3. The Mumbai Metro Rail Corporation (MMRC) now invites sealed Bids from interested eligible Bidders for completion of "Design, Manufacture, Supply, Installation, Tesing & Commissioning and Comprehensive Maintenance Service" of Automatic Train Wash Plant as per the Bid Documents. International Competitive Bidding will be conducted in accordance with JICA's "Single-Stage Two-Envelope Bidding" procedure.

A complete set of the Bidding Documents may be purchased by interested Bidders on the submission of a written application to the address above and upon payment of a non-refundable fee of INR 11,800 (Indian Rupees Eleven Thousand Eight Hundred only) inclusive of GST or USD 170 (US Dollars One Hundred Seventy only) in the form of a demand draft in favour of Mumbai Metro Rail Corporation, payable at Mumbai between 10:00 hrs to 17:00 hrs from 30/09/2022 to 21/11/2022.

The applicants who have downloaded the Bidding Document, shall be solely responsible for checking the website for any addendum /amendment issued subsequently to the issue of Bidding Documents and take into consideration the same while preparing and submitting the bid proposal. **The requisite non-refundable fee as mentioned above** in the form of a demand draft in favour of Mumbai Metro Rail Corporation Ltd., payable at Mumbai, shall be submitted at the the time of submission of Bids.

- 6. There will be no pre-bid meeting.
- 7. Bids must be delivered/ submitted to the address given above on or before 15:00 hrs on 22/11/2022 and must be accompanied by a Bid security of INR 6,00,000/- (Indian Rupees Six Lakh only) or USD 8,000 (US Dollars Eight thousand only) or EURO 8,000 (Euros Eight thousand only) or JPY 1,100,000 (Japanese Yen One million, one hundred thousand only).
