

Invitation for Bids

- 1. The Mumbai Metro Rail Corporation (MMRC) has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Project Mumbai Metro Line 3 (Colaba-Bandra-SEEPZ). It is intended that part of the proceeds of this loan will be applied to eligible payments under Contract for the work as specified at Para 3 below and detailed in the Bidding Documents.
- 2. Bidding will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Bidders from eligible source countries, as defined in the Loan Agreement.
- 3. The Mumbai Metro Rail Corporation (MMRC) now invites sealed Bids from interested eligible Bidders for completion Design, Manufacture, Supply, Installation, Tesing & Commissioning and Comprehensive Maintenance Service" of
 - (a) Synchronized Underfloor Lifting System,
 - (b) Synchronized Mobile Lifting Jacks,
 - (c) Bogie Turn Tables.
 - as per the Bidding Documents. International Competitive Bidding will be conducted in accordance with JICA's "Single-Stage Two-Envelope Bidding" procedure.

A complete set of the Bidding Documents may be purchased by interested Bidders on the submission of a written application to the address above and upon payment of a non-refundable fee of INR 11,800 (Indian Rupees eleven thousand eight hundred only) inclusive of GST or USD 170 (US Dollars One hundred seventy only) in the form of a demand draft in favour of Mumbai Metro Rail Corporation, payable at Mumbai between 10:00 hrs to 17:00 hrs from 07th October 2022 to 30th November 2022.
 - **Alternatively**, applicant can also download the Bidding Documents from the MMRCL's Website: www.mmrcl.com. The applicants who have downloaded the Bidding Document, shall be solely responsible for checking the website for any addendum /amendment issued subsequently to the issue of Bidding Documents and take into consideration the same while preparing and submitting the bid proposal. **The requisite non-refundable fee as mentioned above** in the form of a demand draft in favour of Mumbai Metro Rail Corporation Ltd., payable at Mumbai, shall be payable before or at the the time of submission of Bids.
- 6. There shall be no Pre-bid meeting for this tender.
- 7. Bids must be delivered/ submitted to the address given above on or before 15:00 hrs on 1st December 2022 and must be accompanied by a Bid security of INR 30,00,000/- (Indian Rupees Thirty lakhs only) or USD 38,000/- (US Dollars Thirty eight thousand only) or EURO 38,000 (Euros Thirty eight thousand only) or JPY 5,500,000 (Japanese Yen Five million, five hundred thousand Japanese only).
- 8. Bids will be opened in the presence of Bidders' representatives who choose to attend the opening of Bids along with the authorization from the Contractor at **15:15 hrs on 1st December 2022** at the office of Mumbai Metro Rail Corporation (MMRC), MMRCL Line 3 Transit Office, Wing "A", 'E'- Block, Bandra Kurla Complex, Bandra (East), Mumbai 400051, India.
