Vide above references, you have requested to issue NOC and to allow to carry out the Metro line III constriction work. The NOC and the permission to carry out the said work is at Kalian -Vakola Flyover k is granted subject to the following conditions.

1. The work should be carried out in consultation with Independent Engineer M/s Alia consulting solutions Pvt Ltd. JV with Shrikhande consultant.
2. The work should be carried out in accordance with the methodology and plans submitted to this office. For any deviation to this, the prior permission has to be obtained from MSRDC .
3. The complete safety of the flyover lies with you during construction and after. On that account, an Indemnity Bond should be submitted on Rs.1000 stamp paper before the start of any construction activity.
4. MSRDC desires to resume the pay and park activities below the flyover. Due to ancillary facilities of the metro construction if any revenue loss occurred the same will be compensated by MMRC Ltd. MSRDC will finalise the location of ancillary facilities for more utilization of space.
5. Due to tunnel boaring activities, if surface is damaged or any settlement occurred, the same should be rectified as per the instructions of MSRDC at the risk and cost of MMRC.
6. If any untoward incidents occur during the construction activities and after, the sole responsibility will lie with you only.



7. During the construction if the soil settles, the amount for rectifying the same should be deposited with MSRDC, in accordance with current schedule of rates/market rate plus 25% extra.
8. Temporary structure such as site office, labour camp etc will not be permitted below the flyover.
9. The debris shall be removed on day today basis.
10. In future if any maintenance activity is to be carried out, regarding the said work, prior permission from MSRDC is to be obtained.
11. The space below flyover will remain the property of MSRDC permanently.
12. If any of the above conditions found to be violated, then this NOC will be treated as null and void.
