So, can the tenderer upload the 1st page of the RC book?                       | No, tenderer cannot upload only the 1 <sup>st</sup> page. Tenderer has to upload complete RC book.   |
| 3.         | SMS taxi<br>Cabs                             | Query: Whether bidder can quote the rates of vehicle which are available with them or has to quote the rates for the vehicles mentioned in Financial bid only?            | No, bidder cannot specify any other name of the vehicle during Financial bid. Bidder cannot even put the rates of the any equivalent vehicle against the mentioned name of the vehicle. Bidder has to quote the rates of the vehicle which are mentioned in the Financial bid. |
| 4.         | A. B. Travels                                | Query: Whether bidders get EMD exemption for National Small Industries Corporation (NSIC), Small and medium enterprises (SME) & Micro, Small & Medium Enterprises (MSME). | Yes, tenderer can apply for EMD exemption only if the tenderer uploads the required government certificate. Therefore, it is needed to produce valid certificate.  |

| 5 | SMS Taxi<br>Cabs | Query: How soon will EMD be released?  | As E-tender of vehicle is processed from MMRCL tender portal itself, EMD will be released in short period of time after knowing that the bidder is not qualified for technical/Financial bid.         |

| 6 | SMS Taxi<br>Cabs | Query: What type of vehicles are expected in the tender?   | Indigo & Indica vehicles are used for monthly basis & other types of vehicles (for eg: Maruti Dzire, Honda City, Innova, Bolero jeep, etc.) can be used for On call requirement as and when required. |
| 7 | SMS Taxi<br>Cabs | Query: Why was the earlier tender not successful & if not, why were the bidders not informed about the disqualification? | None of the bidders fulfilled Technical evaluation & hence they were rejected.
