1. The Mumbai Metro Rail Corporation (MMRC) has received a loan from Japan International Cooperation Agency (JICA) towards the cost of Project Mumbai Metro Line 3 (Colaba-Bandra-SEEPZ). It is intended that part of the proceeds of this loan will be applied to eligible payments under the Contract for Part Design, Procurement and Supply, Installation, Testing and Commissioning of ballastless Track on the Mainline from Aarey station (excluded) until BKC station (included) and ballasted Track in the area of at-grade Aarey Station and in the Depot area, excluding the procurement and supply of the rail Fastener System for Mainline of Mumbai Metro Line 3 (Colaba – Bandra – SEEPZ).

Procurement and Supply of Head Hardened rail 60 E1 (UIC 60), 1080 grade HH, Turnouts, Scissor Crossovers and Buffer Stops for the entire Mainline for Mumbai Metro Line 3 (Colaba – Bandra – SEEPZ) including Package 10 B.

The Mumbai Metro Rail Corporation (MMRC) now invites sealed Bids from prequalified eligible Bidders for the design, execution and completion of\_Part Design, Procurement and Supply, Installation, Testing and Commissioning of ballastless Track on the Mainline from Aarey station (excluded) until BKC station (included) and ballasted Track in the area of at-grade Aarey Station and in the Depot area, excluding the procurement and supply of the rail Fastener System for Mainline of Mumbai Metro Line 3 (Colaba Bandra SEEPZ).
