ELIGIBILITY CRITERIA:

1. The bidder shall have valid registration & Electrical License, Valid registration of EPF and ESIC issued by Govt. of India/Maharashtra's competent authority to carry out the work.
2. Average Annual financial turnover during the last 3 years (2020-21, 2021-22, 2022-23), ending on 31st March of the previous financial year, should be at least 80% of the estimated cost.
3. Experience of having successfully completed one Similar (Electrical installation/maintenance) work costing not less than the amount equal to 80% or two works costing 50% each of the estimated cost or three works costing 40% each during previous 3 years up to date of submission of tender.

Note:

- i) The work of providing annual Electrical installation/ maintenance work carried out under single work order in Govt./ Semi Govt. Organization carried out in Govt./ Semi Govt. Organization in MMRC (2020-21, 2021-22, 2022-23) shall be treated as a similar work.
- ii) Certificate of satisfactory completion of similar work shall be issued by officer not below the rank of Executive Engineer. The copy of such experience certificate shall be uploaded by the bidder in e-Envelope 'B' Technical Bid.
