5.	Mr. Satyavan Shendekar, Cheftalk Food & Hospitality Services Pvt. Ltd.	Query: Cleaning of canteen area is a responsibility of Housekeeping or canteen vendor.	Cleaning of Cafeteria will be done by Housekeeping wisely twice in a day. However, cleaning of tables & chairs, utensils and pantry area as and when required shall be the responsibility of the vendor.
